

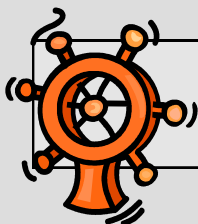

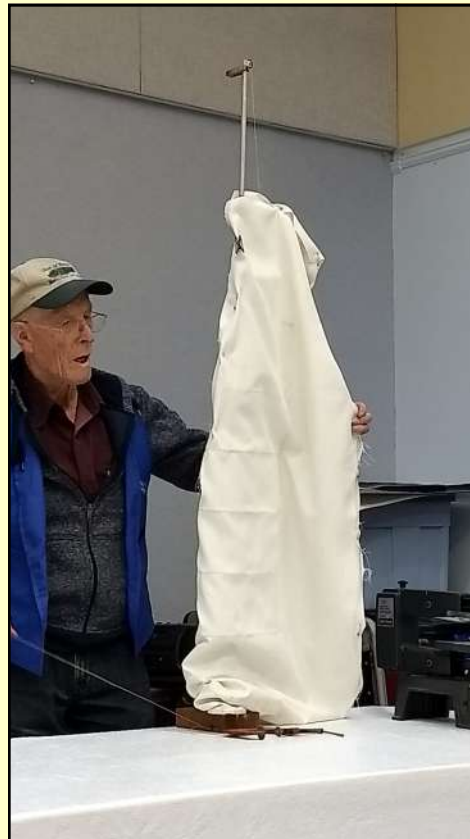

Part 4. - Proceedings at General Meetings

14. Special business is:
- (a) all business of an Extraordinary General Meeting except the adoption of Rules of Order, and,
 - (b) all business that is transacted at an Annual General Meeting, except,
 - I. the adoption of Rules of Order
 - II. the consideration of Financial Statements
 - III. the report of the Directors
 - IV. other business
 - V. the election of Directors
 - VI. such other business as, under these By-Laws, ought to be transacted at an Annual General Meeting, or business which is brought under consideration by the report of the Directors issued with the notice convening the meeting
15. (1) No business, other than the election of a Meeting Chairman and the adjournment or termination of the Meeting, shall be conducted at a General meeting at a time when a quorum is not present.
- (2) If at any time during a General Meeting there ceases to be a quorum present, business then in progress shall be suspended until there is a quorum present.
- (3) A quorum is three (3) Members present, or such greater numbers as the Members may determine at a General Meeting.
16. If within thirty (30) minutes from the time appointed for a General Meeting a quorum is not present, the Meeting if convened on the requisition of Members, shall be terminated, but in any case, and if, at the adjourned Meeting, a quorum is not present within thirty (30) minutes from the time appointed for the Meeting, the Members present constitute a quorum.
17. Subject to By-Law 18, the President of the Society, the Vice-President, or, in the absence of both, one of the other Directors present shall preside as Chairman of a General Meeting.
18. If at a General Meeting there is no President, Vice-President or other Director present within fifteen (15) minutes after the time appointed for holding the Meeting, the Members present shall choose one of their number to be Chairman.
19. (1) Any resolution proposed at a Meeting must be seconded in order to be discussed.
- (2) In the case of an equality of votes, the Chairman shall not have a casting or second vote in addition to the vote to which he may be entitled as a Member, and the proposed resolution shall not pass.
20. (1) A Member in good standing is entitled to one vote when present at a Meeting.
- (2) Voting is by show of hands.
- (3) Voting by proxy is not permitted.
21. A Corporate Member may vote through its Authorized Representative who is entitled to speak and vote, and in all other respects exercise the rights of a Member, and that Representative shall be reckoned as a Member for all purposes with respect to a Meeting of the Society.

MODELLING THE RCN

Over the next few months I will try and show club and non club members models of RCN ships. Any era of ship will qualify. Members who have pictures of their RCN models can forward them to me and we'll do our best to feature them in this column.

This month I am featuring HMCS Haida . Fortunately, Canada has saved this vessel and made it a National Historic site. Now in St Catherine's waterfront, moored at a permanent location for as many people to see as possible.

The Haida is Canada's most celebrated WW II Navel Vessel. The history of the "Tribal Class" destroyers is a fascinating read and the nine Canadian Tribals earned their way through the " Battle of the Atlantic " as well as other areas of hostilities.

The RCN prior to Sept. 6/1939 consisted of 3500 officers and men and a hand full of ships. At the end of 1944 we had 95000 men and women in Navy Blue and 434 ships. This made the RCN the third largest Navy after the USA and Great Briton. It was an incredible growth that symbolizes the great contribution that Canadians made in the cause of peace and freedom during history's largest war.

Picture on the left shows all the stringers in position and faired, ready for strip planking. At the bow I will fit red cedar blocks once the planking is finished. These blocks must be very dry and making a purchase of Kiln Dried material such as Bass wood or Red Cedar is the best way to deal with solid bow blocks.



As you can see, the planking is progressing and gunwales are in position. The gunwales are made up of two layers, laminated in position. This made it possible to easily make the sharp bend at the bow. Adhesive is "Tight Bond #3 ". In my mind a excellent product for hull construction.

The picture on the right shows the bow blocks partially shaped and glued to the bow assembly. I have done this several times and it seems to work. Rasps and course files are used in shaping.



The picture on the left shows the nylon pantyhose covering the hull, with 6 coats of polyurethane over . This does a great job of sealing the hull without adding any appreciably weight. Once the shafts tubes are all in place I do about 5 coats inside the hull.



Now the external skeg is mounted by screwing, glue and plugging through to the keelson . Note the screw and washer at the stern.. I use this system as a clamping crew. It's removed when the glue is well dried and plugged. The hull is now ready for a couple of final coats of ploy before conventional undercoat and final finishing.



The hull is now removed from building board and cleaned out made ready for motors, radio etc. This hull now weighs 2.5 lbs. I would like to have a finish weight of no more 6 lbs without the battery. I suspecting that I'll have to watch my weight build up carefully.
